President's Message

It's hard to believe that my term as President of the APA will soon end. The year has been very busy and much has been accomplished.

Notably, Health Care Reform has passed. The passage is being heralded as historic and certainly has opened the door for substantive change, expanding coverage for about 32 million individuals, phasing out pre-existing conditions, emphasizing the medical home model and age-appropriate services for children, establishing parity to Medicaid and Medicare payment for the first time, and through various provisions introducing the idea that universal coverage for all is the ideal. While we have not yet reached the point of saying as a country that health care is a right, we are closer to that vision. Much work lies ahead in implementing this massive legislation and continuing to improve on our system of health care.



We will be celebrating our 50th Anniversary at the PAS meeting in Vancouver. We have planned for over a year for these events. For the first time this year there will be an Opening Session with the four Presidents of APA, APS, SPR, AAP welcoming the alliance organizations

and the members in attendance. In store is a Keynote Speaker on Global Climate change and a concerted effort to express our unified voice on behalf of children and the collaboration among academic societies. We will have a Membership Meeting on Sunday at 3:30pm followed by a lively debate on health care from the two sides of the border. Our Presidential Plenary will feature the best abstracts, pointed research talks on child health measurement and perinatal care; a dynamic presentation by our Keynote Speaker Cathy DeAngelis, Editor-in-Chief of JAMA, and my Presidential Address entitled Global Child Health: Reaching the Tipping Point for All Children. There are many more activities with platform presentations, poster sessions, workshops, the APA standing committee meetings on Health Care Delivery, Public Policy & Advocacy, Research and Education, Special Interest groups, and of course the delight of networking and seeing old friends.

On March 5, 2010 I attended the invitational meeting entitled *Rebuilding Haitian Medical Education and Training*. Our Global Health Task Force composed of Claibourne Dungy, **Peter Szilagyi**, the chairs of the International Health SIG, **Janet Serwint**, others and I, will formulate plans over the next several months for the APA's contribution to the retraining efforts in Haiti in the context of defining the APA's broad goals for global health. The focus is likely to be our efforts at supporting educational endeavors and using the Haiti experience as a model.

Even though I have been an APA member for over 20 years, I found this year quite exciting and discovered many new insights about our organization. One thing that really stood out to me is the tremendous talent of our members and the cumulative contributions from our SIGs, regions, committees and the identified core functions of APA. I also became aware that we have important contributions to make to members of



other organizations and the powerful products of those collaborations.

The definition of collaboration in Webster's Dictionary is "to work jointly with others or together, especially in an intellectual endeavor". The APA is involved with and has often led countless such endeavors. The APA collaborates with the AAP, APS and SPR through the Pediatric Academic Societies meeting to create a venue for dissemination of research, educational scholarship and opportunities to enhance life long learning for all its members. Additional collaborations with both pediatrics and other disciplines have included the Hospitalist meeting (SHM, AAP, APA), meeting with legislative aids about health care reform (AAP, APA), participating in the Patient Centered Medical Home Meeting (SGIM, STFM, AAP and APA) and countless others.

As an APA Core activity, the program is designed to strengthen fellowship training in Academic General Pediatrics (AGP) by establishing an accreditation process which has curriculum guidelines and program standards for fellowship training. Through the process of accreditation we hope to enhance education and thereby attract the “best and brightest” residents to the discipline of AGP. Importantly AGP programs come in many stripes and colors and include programs focused on health services research, clinical effectiveness, quality and safety, community pediatrics, environmental health, and hospital medicine.

Educational Scholars Programs

The Educational Scholars Program (ESP) has much to celebrate at PAS this year! First, we will be giving graduating scholars from Cohort 1 and Cohort 2 their Certificates of Excellence in Educational Scholarship at the APA Business Meeting on Sunday, May 2. Cohort 2 projects are all focused on education in community pediatrics; this group was sponsored by the AAP’s Community Pediatrics Training Initiative-Dyson Foundation.

Second, we will be welcoming a new cohort of 18 ESP scholars (Cohort 4), who represent the fields of general pediatrics, pediatric hospital medicine and emergency medicine, and several pediatric subspecialties. All scholars complete a scholarly educational project over the three years of their time in the program, and graduate after they have an accepted peer-reviewed publication or presentation on their project. An exciting array of project topics has been proposed by Cohort 4 scholars:

- Formalizing, Implementing and Evaluating a Community Pediatrics Curriculum For Residents
- A Longitudinal Community Violence Prevention Curriculum for Pediatric Residents
- Evaluating Didactic Curriculum Revision to Improve Medical Knowledge in a Community Based Medical School
- Anticipatory Guidance about Violence Prevention: The Influence of Physician Attitudes and Practice Characteristics
- The Development and Assessment of an Art Observation Curriculum for Medical Students
- Educational prescriptions: teaching residents how to pose relevant clinical queries
- Exploration of critical incidents and other triggers that prompt creation of learning goals during a fourth year sub-internship rotation
- Using Social Networking Sites as an Educational Tool for Pediatric Residents
- Pocket Tool to Evaluate Professionalism
- Teaching evidence-based communication skills to pediatric faculty, fellows and residents
- Pediatric hospitalist curriculum for residents: development, implementation, and evaluation
- Creation and Evaluation of a Web-based, Educational Curriculum for Pediatric Hospital Medicine Fellows
- Pediatric Intensive Care for the General Pediatrician: Developing a Curriculum for Resident Education in Pediatric Critical Care
- Development and Evaluation of an Intensive Resuscitation Curriculum for Pediatric Residents
- Addressing the Performance Gap: A Simulation-based Curriculum Focused on Pediatric Emergencies for Family Medicine Residents.
- Development of a Multi-institutional Online Pediatric Emergency Medicine Curriculum

The ESP will also greet 9 faculty advisors for Cohort 4, who will meet with their assigned scholars over the three years of the program to help them to complete their ESP projects, develop educator portfolios, and strategically plan their careers as educators. We are proud that six graduates of the ESP now serve on our faculty.

This year, the ESP program session at PAS will include two didactic/interactive segments:

1. **Program Evaluation** will cover conceptual approaches to evaluation planning, as well as quantitative and qualitative evaluation methods.
2. **Turning Scholarly Projects into Scholarly Products** will address the design and implementation of platform and poster presentations, workshops, and scholarly articles.

In addition, the scholars will share plans and progress on their ESP projects over a 2-hour **Networking Luncheon**, which is an annual event of the program.

We are very grateful to our 37 ESP faculty, who volunteer their time to help young educators grow and thrive! We also appreciate the confidence of our 79 new, current and former scholars, who have joined our program to develop their skills and share their insights as we build a strong community of educators within the APA.

The ESP's hard working Executive Committee includes: Connie Baldwin, ESP Director; **Latha Chandran**, Co-director for Curriculum and Evaluation; **Maryellen Gusic**, Co-director for Research; **Elisa Zenni**, Chair of the

Faculty Advisor Committee; **David Keller**, Cohort 2 Leader; **Mary Ottolini**, Cohort 3 Leader; and **Teri Turner**, Cohort 4 Leader. They devote many hours each month to the ongoing success of this program.

Liaisons

Council on Academic Societies(CAS)

I have been privileged to represent the APA to the Council on Academic Societies (CAS) of the Association of American Medical Colleges (AAMC). We are one of about 90 societies that represent the interests of faculty and are part of the AAMC governance. I serve on the Administrative Board of the CAS and I am CAS liaison to the Group on Faculty Affairs (GFA) of the AAMC as well. I transmit weekly listserv information to the APA-Listserv from the AAMC-CAS. Recent CAS initiatives that will likely be of interest to APA members include:

CAS Initiative to High light Faculty Innovations: The CAS, as a voice for faculty through academic and scientific societies, is proposing to provide a forum for faculty to highlight, discuss, and facilitate thoughtful, feasible, forward-looking innovations – which may range from collecting and disseminating on-going innovations, to recommending to AAMC how it can assist institutions manage regulatory and administrative burdens, to new innovations on enhancing communication and respect across disciplines. Anticipated project outcomes include: 1) The identification, consideration, and dissemination of innovations that address issues of concern to faculty and other institutional leaders; 2) The engagement of a broad spectrum of faculty in CAS-led leadership activities; 3) Creation of a cohort of faculty members more engaged in promoting change and innovation at their institutions; and 4) internal and external recognition of the CAS as a productive catalyst for innovation.

CAS Leadership Development Initiative: CAS is developing plans to sponsor an invitational workshop at the 2010 AAMC Annual Meeting featuring selected CAS society officials and staff discussing their leadership development objectives, programs, lessons learned and perceived needs; selected institutional officials (faculty affairs deans, chairs, others) discussing institutional leadership development objectives, programs, and perceived needs; selected faculty and residents discussing their leadership objective priorities; and breakout sessions in specific development areas to articulate priority program objectives. The tentative plans are to follow that session with a full day pre-meeting leadership development session at the 2011 CAS and ORR Spring Meeting to: 1) showcase various leadership development modules from societies and institutions; 2) discuss how such modules can be best used by CAS representatives and societies with their members and what AAMC and the CAS can do to facilitate such programs; and, 3) discuss evaluation and outcome measures

CAS Initiative to Increase In volvement of Junior Faculty : CAS has been considering various ways to engage early and mid-career faculty in the CAS's deliberations. A number of mid-career faculty were invited to participate in the 2010 CAS Spring Meeting in Austin. This winter, CAS member societies were asked to consider advancing early- and mid-career faculty should a CAS representative vacancy occur and if the society's membership allows. This suggestion was an effort by CAS leadership to facilitate succession planning

as well as to ensure that the full range of faculty are represented in the CAS's deliberations. Finding ways to engage former members of the Organization of Resident Representatives are also been considered.

Here are the brief description of the presentations and the workshop:

1. e-Learning SIG Wiki (Presenter: Kadriye O. Lewis, Ed.D)

This presentation will introduce the e-Learning SIG Wiki developed by Dr. Kadriye O. Lewis. The live demonstration will cover all the unique features of this Wiki including how to collaborate and share resources with the rest of the e-Learning SIG members.

2. Enhancing Proficiency in Otitis Media Diagnosis (Presenter: Nader Shaikh, MD, MPH)

This presentation will share information about a self-instructional e-learning tool, called ePROM (Enhancing Proficiency in Otitis Media). The presenter, as one of the authors of this tool will discuss the challenges with diagnosing otitis media including the evaluation of the efficacy of the program.

This presentation will showcase products for creating navigable online learning objects. (*Learning object means self-standing, re-usable units of learning that meets an instructional objective.)

4. Johns Hopkins Harriet Lane Continuity Clinic Curriculum / Internet Learning Center (Presenter: Maggie Moon, MD, MPH)

This presentation will introduce an interactive, internet based curriculum for continuity clinic / general ambulatory pediatrics at Johns Hopkins. The presenter will share the information on how 30 modules are updated annually, with hyperlinks to relevant articles and/or video material. The pre/post test comparison data for each module will be discussed.

5. Online Evidence-Based Medicine Tutorial (Presenter: Martha Wright, MD, M.Ed)

EBM skill development is a core competency of resident training. A wide variety of activities have been designed to teach EBM skills during residency. This presentation will introduce a 3-year longitudinal, integrated, multi-method curriculum on EBM skills. It includes completion of an on-line tutorial on EBM skills designed specifically for pediatric residents that provides the content knowledge and skill practice. The results of this study will be shared.

6. Workshop: Online Identities and Their Role in Shaping a Professional Image: Demystifying Web 2.0 (Presenter: Erik Black, PhD; Heidi Saliba, BA; Lindsay Thompson, MD MS)

This one hour workshop will address health care professional's concerns about online identities with respect to issues of patient care, reputation and interpersonal connections. The workshop will discuss the relationships between a person's online (virtual) profile, his or her real-life experiences, and the image that is shaped as a result of this interplay. The presentation will provide a format to discuss a working social networking policy statement currently employed by the University of Florida Health Science Center.

Literacy Development Program in Primary Care

The Literacy Development Programs in Primary Care SIG will meet Saturday, May 1st, from 2:45-4:45, to discuss strategies and approaches for incorporating books, literacy promotion, and other aspects of language development and school readiness into primary care practice. This year's healthcare policy proposals have guaranteed changes within the American healthcare system for patients, hospitals and doctors. Join us to discuss United States healthcare reform and how it will impact residency programs and pediatrics residents.

Presenters at the AMA's 2008 policy-making meeting highlighted an expected primary care physician shortage of 35,000-40,000 by 2025. US medical schools trained no more than 16,000 physicians a year until about a decade ago, according to data from the Association of American Medical Colleges. In a June 2006 report the AAMC called for a 30% increase in accredited medical school enrollment by 2015. Total enrollment for 2008 was 18,036, representing an increase of 11.5 percent in the past decade. How will healthcare reform affect these numbers? How will it affect residents, and residents in pediatrics in particular?

D-B Screening in EHRs

Developmental-Behavioral Screening and Surveillance in an Electronic Records Environment

Electronic records create challenges for continued deployment of paper-pencil measures. Hand-scoring followed by scanning protocols is a slow and expensive process. Ongoing surveillance (e.g., tracking milestones progress or providers' responses to parents' concerns) requires repeated scanning of test forms; rendering an image that is increasingly illegible.

What are the alternatives? Many publishers and some electronic health records (EHR) vendors/subcontractors now offer fully electronic applications of developmental-behavioral measures. A list of these services and the tools available is provided below, along with a description of the challenges and benefits of online services.

Advantages of online developmental-behavioral measures

All online measurement services: a) automate results; relieving providers of time-consuming hand-scoring; b) generate referral letters and in some cases, summary reports for parents; c) most identify relevant ICD-9 and procedure codes to optimize reimbursement; d) most facilitate data aggregation (e.g., have searchable, sortable, exportable databases) which are helpful for quality improvement initiatives, finding records of patients seen in multiple clinics, etc; and e) all services offer trials so that providers can view the characteristics of each. Results, across all online services, are returned in real-time, i.e., instantly, meaning at the speed of light. Although developmental-behavioral measures are somewhat more costly than their paper-pencil counterparts, expenses are offset by prodigious time-savers (e.g., automatic scoring, documentation, improved reimbursement, etc.).

Disadvantages

Providers understandably wish to have patient records "automatically" populated with results from developmental measures. Such seamless integration requires simultaneous support from information technologists on both sides: Publisher/vendor working alongside IT consultants for electronic records software.

Sadly, pediatric electronic records have not enjoyed the intensity of software customization efforts as have internal medicine and family practice. But, there is surely “strength in numbers” (e.g., participating in EHR software support groups, if not frequent badgering). Without true integration, providers need a few simple techniques, i.e., how to: a) keep a browser open to the online service,; b) select and copy essential information; c) switch back to the electronic record software; and d) then paste in results. More substantive disadvantages are the limited availability of translations (e.g., in many cases, online screening services are only available in English), meaning that providers or staff may need to translate before submitting answers. Nevertheless electronic offerings in languages other than English are evolving rapidly.

Below is a list of online developmental-behavioral screening and surveillance services, links, to sites, and descriptions of measures provided. Service listed include only publishers/vendors offering tests that meet standards for screening test accuracy and thus identify the vast majority of children with and without probably problems. Almost all services depend on copyrighted tools meaning that paper-pencil versions cannot be included in electronic records without working through publishers or their vendors.

Electronic Records Options for Developmental Screening and Surveillance with Quality Tools*

(including online and other digital approaches to administration and scoring).

Essential definitions are:

Tablet PC--approaches that typically require a stylus to select among multiple choice answers only;

Keyboards –approaches enabling users select multiple choice responses but also type in text-based answers to questions

Touch-screens applications-- these often allow parents to listen to questions and response options and then touch a simple response box (e.g., yes/no) thus reducing literacy demands;

Online –meaning hosted on a website and thus requiring an internet connection, preferably high speed;

PDA—personal digital assistant such as a Palm Pilot or Blackberry usually requiring users to be online, with or without a keyboard

CD-ROM--offline but still electronic, and requiring installation on the users’ computer and for user to install updates

Parent Portal – online applications wherein parents can complete measures but do not see results.

Rather these are seen by secure logon by clinicians; May also refer to a personal website for the parent.

Interactive Voice Response (IVR) – telephone administration through which multiple-choice screens can be administered.

Data Aggregation—almost all electronic applications create a database either online or on individuals’ computers (in the case of CD-ROMs) where all administered screens can be viewed, overall results summarized, etc. Some web-based scoring services provide exported files (e.g., EXCEL compatible) to allow users to view overall results. In all such applications, an administrator of multiple sites can view all results

Webcasts/webinars/training videos—These training options online, either live on a specific day or constantly available on publisher’s websites.
